

Statutes amending the study and examination regulations for the International Computer Science BSc degree programme at the Ostbayerische Technische Hochschule Regensburg

Please note: this English version is not a legally binding document, only the German version is legally binding.

Based on Art. 9 sentence 1 in conjunction with Art. 80 para. 1 sentence 1, Art. 84 para. 2 sentence 1 and the Bavarian Higher Education Innovation Act (BayHIG) of 5 August 2022 (GVBl. p. 414, BayRS 2210-1-3-WK), which was last amended by § 2 of the law of 24 July 2023 (GVBl. p. 455), the Ostbayerische Technische Hochschule Regensburg (University of Applied Sciences) issues the following statutes:

§ 1

The study and examination regulations for the International Computer Science BSc degree programme at the university dated 17 April 2023 are amended as follows

1. In § 1, the words "21 August 2014" are deleted and replaced by the words "10 August 2023".
2. In § 3 para. 1, the words "state universities of applied sciences of the Free State of Bavaria in accordance with the Qualifications Ordinance (QualV)" are deleted and replaced by the words "universities in accordance with the Ordinance on Qualifications for Studies at Universities of the Free State of Bavaria and State-recognised non-state universities (Qualifications Ordinance - QualV)".
3. In § 7 para. 1, the number "11 a" is replaced by the number "6".
4. a) The following new paragraph 5 shall be added to § 11:

(5) "1 The completion period may be up to five months if the Bachelor's thesis is submitted no later than five months before the end of a semester in which at least one other compulsory or compulsory elective examination is to be completed in addition to the Bachelor's thesis. 2A corresponding application must be submitted to the Chair of the Examination Board."

b) The current paragraph 5 becomes paragraph 6, the current paragraph 6 becomes paragraph 7, the current paragraph 7 becomes paragraph 8.
5. In § 12 para. 1, "§ 7 para. 2 sentence 3 RaPO" is replaced by "§ 30 APO".

6. The table in the appendix is amended as follows under I. Overview of modules, certificates of achievement and credits in the first stage of the programme:
 - a) For module 4A "Language Track A - German as a foreign language 1", the number of SWS in column 4 in the top line is replaced by "4".
 - b) For module 5A "Language Track A - German as a foreign language 2", the number of SWS in column 4 in the top line is replaced by "4".

- c) For module 10, the English module name in column 2 is changed to "Computer Networks".
- d) In the row "Totals for first study section", the number of SWS in column 4 is replaced by "48/52".

¹These statutes enter into force on the day following their announcement. ²§ Section 1 no. 4 applies to all students who are enrolled on the degree programme at the time it comes into force. ³Otherwise, the statutes apply to all students who commence their studies after the effective date.
